NOTICE OF NOMINATION OF CANDIDATES FOR ELECTION OF FOUR VETERINARY SURGEONS AND THREE VETERINARY PARAPROFESSIONALS TO KENYA VETERINARY BOARD

In accordance with the Veterinary Surgeons and Veterinary Paraprofessionals (VSVP) Act Cap 366, Section 4 (f), (g) and VSVP Regulations 2013, Part II, notice is given that nomination of candidates for the election of four veterinary surgeons and three veterinary paraprofessionals to the Kenya Veterinary Board (KVB) will be on **Friday 5th January 2018**.

Nomination forms (Form 1 and 2), in First Schedule of VSVP Regulations 2013 can be obtained from the Kenya Veterinary Board offices located at Kabete Veterinary Research Laboratories, Nairobi during normal working days between 8:00am – 5:00pm or can be downloaded from the KVB website

NOTE:

1. Only persons who are registered by the Board, duly retained in 2017 and their names appear in the voters register on the date of this advertisement will be eligible to be nominated or to nominate candidates.
2. Each eligible person is entitled to nominate only four candidates for veterinary surgeons and three candidates for veterinary paraprofessionals as per Section 4 (f) and (g) of the VSVP Act, Cap 366.
3. All candidates will comply with **Chapter 6 of the Constitution** and will present the following documents on the nomination day:
 - i. Tax Compliance certificate from Kenya Revenue Authority (KRA)
 - ii. Certificate of good conduct from Criminal Investigation Department (CID)
 - iii. Clearance certificate from the Ethics & Anti-Corruption Commission (EACC)
 - iv. Clearance certificate from Higher Education Loans Board (HELB) where applicable
 - v. Clearance from Credit Reference Bureau
4. A separate form shall be used for the nomination of each candidate and shall be signed by a nominee, proposer and a seconder who should be eligible to nominate as in **No.1 above**.
5. Completed nomination forms for candidates and other listed documents in **No. 3 above** shall be lodged with the Registrar, Kenya Veterinary Board at Board offices in Kabete Veterinary Laboratories on **Friday 5th January 2018** before twelve noon (12 pm).
6. The voters register is available on the KVB website or at KVB office for perusal from the date of this advertisement.
