Pursuant to Section 4(1)(f) and 4(1)(g) of the Veterinary Surgeons and Veterinary Paraprofessionals Act Cap 366, notice is hereby given for election of four (4) Veterinary Surgeons and three (3) Veterinary Paraprofessionals respectively for appointment to Kenya Veterinary Board from 2018 to 2020. The election will take place on **Tuesday 13<sup>th</sup> February, 2018**.
